## ADA HEARING IMPAIRED PRODUCTS & SERVICES

### Changes to ADA Requirements for Hotel & Motel Guest Rooms.

Effective March 15, 2012, the Federal Americans with Disabilities Act (ADA) will be changing the accessibility requirements for Hotels and Motels. The ADA requires that all hotels and motels provide guest rooms accessible to individuals with physical disabilities. The ADA has specific language and requirements for Hearing Impaired accessibility.

Hotel and Motels are now required to disperse the Hearing Impaired accessible guest rooms among the various types of guest rooms offered based on type, number of beds and amenities. This means that hotels and motels are not able to make all mobility (wheelchair) accessible rooms Hearing Impaired accessible nor are they able to limit Hearing Impaired accessible rooms to one floor, queens, kings, smoking, and non-smoking. The Hearing Impaired accessible guest rooms must be DISPERSED among the various types of guest rooms offered.

### TELEPHONE SIGNALER

- Connects to telephone jack and lamp
- Flashes lamp when telephone rings
- Lamp can be turned on/off using control on Telephone Signaler



### DOOR KNOCK SIGNALER

- Hangs over top of hotel room door
- Vibration sensor for knock on door
- Flashes LED light to signal door knock
- Requires 9V battery (not included)



### ALARM CLOCK WITH SHAKER

- Amplified Alarm Buzzer
- Power jack for Bed Shaker (included)
- Optional 9V back up battery (not included)



### TELEPHONE AMPLIFIER

- Connects between base and handset of corded guest room phone

- Requires 2 AAA batteries (not included)



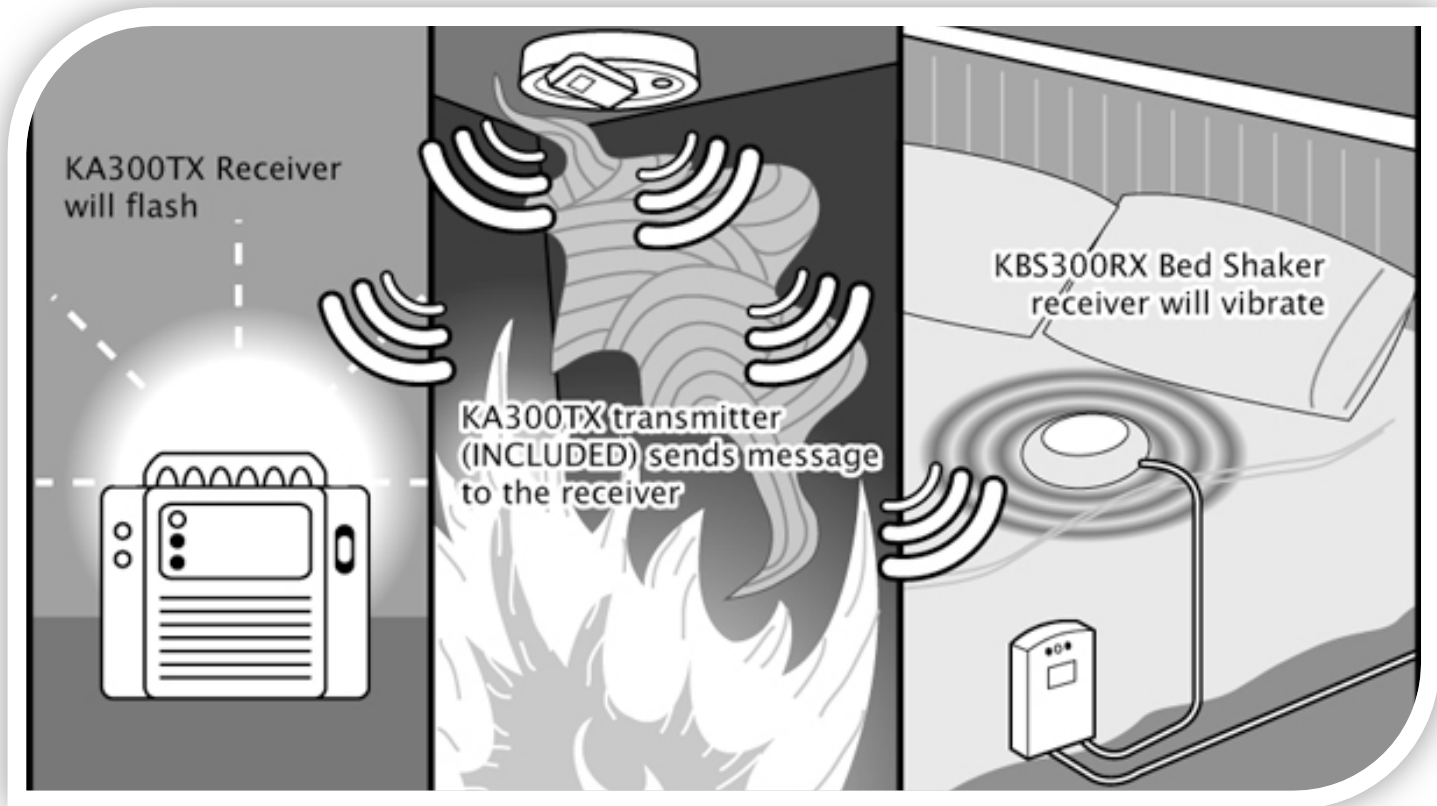

## THE FIRE ALERT KIT

Model: KA300

The Wireless Alarm Monitoring KA300 System is designed to bridge the gap between existing warning devices designed for those without a hearing loss. The KA300 system provides a complete reliable source for Deaf and Hard of Hearing individuals to be alerted during emergency situations.

The KA300 System connects up to 3 audible alarms such as fire/smoke alarms, carbon monoxide alarms, home security systems, weather alerts and any other audible alarm into one monitoring system. It's the first flexible alarm monitoring system on the market designed to fit small, medium or large scale buildings and is an ideal product to make a hotel, dormitory, apartment, home or office accessible.

The KA300 system is a fully wireless system that is easy to install without the cost of re-wiring the building. The KA300TX transmitter connects directly to the existing alarm. When activated, the KA300TX sends a wireless signal to the KA300RX sound and strobe receiver and the KBS300RX, bed shaker receiver. Both the KA300RX and the KBS300RX receivers function with both an AC power adapter and a 9Volt battery backup in the event of a power outage. The KA300RX sound and strobe receiver is equipped with ultra-bright LEDs that will alert while the KA300RX is functioning solely on the back up battery.

# ADA COMPLIANT POOL LIFTS

Hotels and Motels are now required to have a ADA compliant pool lift for each body of water (pool or hot tub) on a given property. On July 26, 2010, the US Department of Justice released updated ADA Standards for Accessible Design. Among the updates for a number of facility types were new requirements specifically for public swimming pools. The level of accessibility depends on the size and type of the pool. For pools under 300 linear feet in size, the ADA Standard for Accessible Design calls for one means of access, which must be either an ADA-compliant lift, or a sloped entry
